

**Hamilton Yacht Club (Inc) Annual General Meeting  
1930hrs, Tuesday, 15<sup>th</sup> June, 2010**

1. **Attendance:** W de Lange (Chairperson) and sixteen members of the yacht club.
2. **Apologies:** B Smith, D Smith, R Gibson, S Kearns, J Little, H Curtis, K Kirby-Curtis, G Meneer, V Moon, N Oxborrow, S McHardie, N Wood.
3. **Minutes of the previous meeting;**
  - J Curtis commented that he had chaired the meeting and that an attendance record had been circulated, but the names had not been noted in the minutes.
  - Apologies from V Moon, who name was misspelled.  
With these corrections, the minutes were accepted as a true and correct record of last year's meeting. *de Lange/Hunter*
4. **Commodores Report;** A written report had been circulated with the agenda. W de Lange highlighted the following;
  - An algal bloom in the lake around the time of the Hamilton regatta resulted in the club carrying out its own water testing an affected attendance at the Hamilton regatta.
  - The Mid-Winter Ball was an innovative and positive experience for the club, with other ideas for fund raising and social activities to be tried in future.
  - Grants from WelTrust, (coaching), Southern Trust (Motors) and BP (fuel) were acknowledged as making a great deal of difference the club.
  - Specific people acknowledged were Sarah Gordon, Karen McHardie, Roger Gordon, Murray Borland and Kay Kirby-Curtis. Dave Smith, Laurence Fisher, Kim Ang and Brian Smith had also provided notable support.
  - The meeting accepted the report. *de Lange/Paine*
5. **Treasurer's Report:** G Hunter tabled his Treasurer's report and spoke to its contents including proposed subscriptions for the coming season, locker fees and the potential impact of the GST rise to 15%. Overall the club's financial position was satisfactory.  
This prompted a discussion on the level of the locker fees, bar prices, club hire and GST.

The Financial report, subscription recommendation and locker fees were accepted by the meeting. *Hunter/Curtis*
